Sub: Forests – Wildlife – Pilot Project on “Beehive fences to deter crop raiding elephants” in Coimbatore Forest Division – An amount of Rs.115.00 lakh sanctioned during 2018-2019 – expenditure not incurred – Revalidation proposal for the year 2019-2020 – Reg.

However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2019-2020. The Principal Chief Conservator of Forests is directed to include this term of expenditure while sending the proposal for Revised Estimates / Final Modified Appropriation 2019-2020 and also send draft explanatory note for inclusion of the expenditure in the Supplementary Estimate to Government in Finance (AHD&F / BG-1) Department without fail.
